## Supplementary Notes

## Status of the Kirkby Scout Centre

The Kirkby Scout Centre is part of the Parish Hall building, of which the Kirkby Parochial Church Council has de facto ownership. The Scout Group is obliged to maintain the property fully in lieu of paying rent. A formal lease agreement to this effect is currently under negotiation.

## Status of bank accounts

The Scout Group now operates four Barclay's bank accounts. Each section operates its own account for ease of adminsitering programme expenditure. There is strong encouragement to keep the cash accounts as low as possible and utilise the bank accounts as a more stable and secure method of sectional accounting. The main Lloyd's TSB Group Bank Account has been closed with all balances transferred to the Barclay's Group Bank Account through which the administration of the Group is undertaken.
