Supplementary Notes

Status of the Kirkby Scout Centre

The Kirkby Scout Centre is part of the Parish Hall building, of which the Kirkby Parochial Church Council has *de facto* ownership. No formal lease has yet been agreed, negotiations regarding the future of the Scout Centre are ongoing.

Emergency Loan from Altside Scout District

Due to the difficult circumstances the Group found itself in following the fire at the Scout Centre, details of which can be found in the Trustee's Annual Report, the Group requested a £1500, 9 month loan from Altside District Scout Council. It was agreed and provided with a requirement that it would be repaid in three instalments of £500, to be made at the end of April 2013, end of July 2013 and end of October 2013.

Status of bank accounts

The Scout Group now operates four Barclay's bank accounts. Each section operates its own account for ease of adminsitering programme expenditure. There is strong encouragement to keep the cash accounts as low as possible and utilise the bank accounts as a more stable and secure method of sectional accounting. During the course of the year the Kirkby Black Scouts Explorer Scouts has grown. Their Lloyd's TSB Bank Account has been reclaimed and the section has been "absorbed" into 1st Kirkby Scout Group for accounting and operational efficiency.

Accounting Adjustments Within Cash Accounts

When collating the accounts there were several instances where the administrators for the cash accounts needed to make adjustments to keep the balance and contents of the cash account in agreement. In the name of transparency the total adjustments are summarised here.
